- Athletic Policy: Motion made by S. Brown to accept the Athletic policy as written, minor changes. Supported by H. Borseth. All in favor. None opposed. Motion carried.
- i. Hire Custodian/Bus Driver: Motion made by S. Brown to hire Thomas Jacobson as our Custodian/Bus Driver, bus driver role pending passing driver test. Supported by M. Urbis. All in favor, none opposed. Motion carried.
- j. Bus Supplies: Motion to approve ~\$1639.00 for bus supply quotes that includes purchase of paint and other required maintenance items for the school buses, made by S. Brown. Supported by M. Brown. All in favor, none opposed. Motion carried.
- k. Ontonagon County Board Covered under administrative report. Ontonagon County miscalculated State Aid for Students for Ontonagon and Ewen Trout Creek School Districts. This resulted in a 3 year miscalculation of aid provided to the schools. E-TC now has a \$5,500 monthly payment for the next 3 years to account for this mistake made by Ontonagon County. We are awaiting a formal response and resolution from the County on the issue. No communication has been received thus far.
